

CODE OF CONDUCT FOR SUPPLIERS

The REVIGRES Code of Conduct for Suppliers lays down the attitudes and commitment to respect and improve performance in relation to:

1. Child Labour

Suppliers shall not engage in any form of child labour in their organization. "Child" means any person below the age of 15 years (or 14 years depending on the local laws in force), less than the age of completion of compulsory schooling or the minimum permissible age for labour in the relevant country.

Suppliers must ensure that under age employees, who have not completed compulsory schooling, have time to study and that workers below the age of 18 do not perform dangerous work.

2. Forced and Compulsory Labour

Suppliers shall not engage in forced or compulsory labour or work in degrading conditions.

3. Health, Safety and Environment

Suppliers shall comply with all applicable health, safety and environmental requirements by planning activities and providing resources and means to ensure safe and healthy working conditions and respect for the environment.

Freedom of Association & Right to Collective Bargaining

Suppliers shall uphold workers' right to the freedom of association and the right to collective bargaining.

5. Discrimination

Suppliers shall ensure that hiring, salary, benefits, progress, dismissal and retirement are based on ability and not on beliefs or any other personal characteristics.

6. Disciplinary Measures

Suppliers must treat all workers with dignity and respect. The Providing Company shall ensure a workplace free of hostile and inhumane treatment, harassment or sexual abuse, physical punishment or torture, physical coercion or verbal abuse, and any threat of such treatment.

7. Hours of Work

Suppliers must comply with the laws applicable to working hours and public holidays in the communities where they carry out their activity. The normal working week shall be as defined by law, and overtime work cannot exceed 12 hours/week, except when in extraordinary circumstances of the business it has been voluntarily agreed upon and/or collectively bargained.



8. Wages

Suppliers must pay workers at least the minimum wage required by law and provide all legally determined benefits. Employees shall be compensated for overtime work calculated on the basis of the rate in force or, in countries where the law does not specify any rate, at least the rate equivalent to their normal hourly wage.

9. Management System

REVIGRES favours Suppliers whose management systems meet the requirements established in this Code of Conduct for Suppliers, which ensure compliance with applicable laws and foster continuous improvement.

The code of conduct sets the minimum requirements and we assume that our suppliers apply this standard or other higher standards and acknowledge that:

- These requirements shall also apply to their subcontractors;
- REVIGRES representatives may visit the facilities where suppliers manufacture for REVIGRES;
- Failure to comply with the code of conduct shall be regarded as grounds for just termination of the agreements entered into.

Therefore, we ask that you provide us with the relevant certificates and reports where required to confirm compliance with this code.



TABLE OF REQUIREMENTS

The following requirements must be considered when choosing a new supplier, product or service. All evidence of compliance with the purchase requirements must be provided before the first purchase or provision of the service.
