DECLARATION OF COMMITMENT

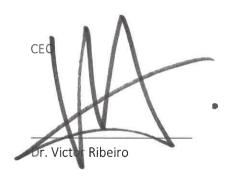

Purpose

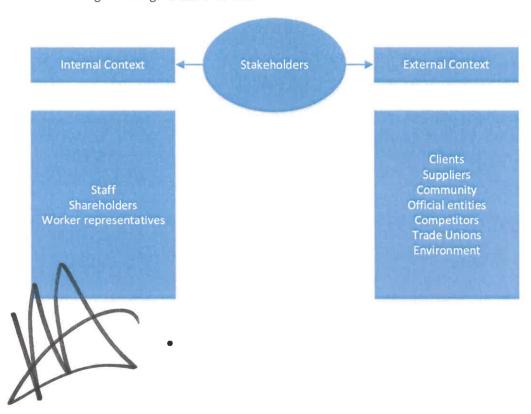

Scope

The code of ethics of REVIGRÉS applies to the whole organisation and in all locations where REVIGRÉS is legally represented, to stakeholder relationships and to the effects of the life cycle of the goods and services delivered to society. It is also understood that it shall be made available to inform and guide people and entities collaborating with Revigrés.

This Code of Ethics conforms to the principle of subsidiarity, i.e. compliance with it does not prevent the simultaneous application of the deontological rules of specific professional groups, nor of the applicable sector codes.

Environmental Protection

GENERAL ETHICAL PRINCIPLES

Revigrés manages its activities by applying the General Principles of Ethics which shall prevail over all other principles in all circumstances:

Full respect of the Law and rules in force;

Full respect of Conventions and internationally recognised Declarations;

Adoption of the Precautionary Principle in actions that may cause irreversible public or environmental damage, adopting conservative assumptions (tested and validated);

Listening to stakeholders and acting in accordance with their concerns;

Continuous improvement of performance in the context of social responsibility.

REVIGRÉS applies the principle of non-regression, that is, it does not use the provisions of the implemented social accountability standard as a basis for reducing the levels of performance in social accountability previously achieved.

The quality of social responsibility management depends on the implementation of the Operating Principles of Ethics:

The scope of the direct and indirect elements of social responsibility identified;

The relevance/significance of the elements of social responsibility;

Factoring in aspects of social responsibility in decision-making;

Accountability and transparency in Stakeholder communication.

Broad social commitments

- Management functions carried out with dedication, zeal and integrity, contributing to the sustainable development, progress and well-being of society, fulfilling responsibilities towards society;
- Fairness and honesty in professional business engagement and personal conduct as representatives of Revigrés;
- Co-operation between all employees for team growth;
- Continuously adjusting to a fastchanging context in order to adapt our actions and act in harmony with the environment.
- Recognition of human rights as fundamental principles applied to relations with all its stakeholders and in accordance with international conventions, treaties and initiatives such as the United Nations Universal Declaration of Human Rights, the International Labour Organisation and the Global Compact.
- Respect for the right of association of all employees.
- Compliance with the laws, regulations and collective labour agreements applicable to the sector namely with regard to working hours, remuneration and health and safety at work.

- Respect for equal opportunities for all and implementing procedures that prevent discrimination or differentiated treatment on the basis of race, gender, sexual orientation, creed, marital status, physical disability, political orientation or opinions of another nature, ethnic or social origin, birthplace or trade union membership.

RULES OF CONDUCT

Revigrés' social responsibility is understood as the contribution of the business to sustainable development through proactive management of the environmental, social and economic impacts of its activities.

We commit to conducting our business based on transparent practices, of integrity and solidarity with all stakeholders and we expect the same attitude from our partners. To this end, REVIGRÉS has laid down rules of conduct which reflect core behaviour and foster the fulfilment of the corporate mission, in line with its system of values and ethical principles. These rules were established according to REVIGRÉS's capacity to influence stakeholder groups, independently of culture and habits in the case of foreign stakeholders.

CODE GOVERNANCE

Social Responsibility Committee

The CSR committee is chaired by the Manager of the Social Responsibility Management System and reports directly to the CEO.

The Committee ensures:

- Annual review of the Code of Ethics;
- Handling of claims concerning the breach of the Code of Ethics;
- Ensuring confidentiality of the information received, as long as none of the general principles are undermined;
- Conducting investigations to support decision-making;
- Reporting to the Management Board serious events in which the Code of Ethics was breached.

Procedures in view of doubts and problem-situations:

All doubts, conflicts or breach of the principles in the Code of Ethics shall be reported to the CSR Committee through the Social Responsibility Manager.

Acceptance of the Code of Ethics

Upon reception of the Code of Ethics of REVIGRÉS, the Stakeholder takes note of and agrees with its contents.

The Stakeholder undertakes to comply with the Code of Ethics and acknowledges that any breach of this Code, of the policies and rules of REVIGRÉS will be analysed and subject to appropriate sanctions.
